Higher ranking will be given to existing projects with <u>1-bedroom units</u> located in the city limits of Yuba City; however, projects outside of the preferred scope will be considered.

If applicable, all financing of project costs and operating expenses will be the responsibility of the owner. Rents that are established for the project will be commensurate with other comparable rents for similar rental units in the areas in which the project is located. In all cases, however, rents cannot exceed the maximum allowable HUD Fair market Rent published for Sutter County.

The PBV units will be leased to eligible low income households referred by RHA or to eligible tenants in occupancy of the unit at the time of the submission of the proposal. **Rental assistance is available for a total not to exceed 10 units.**

Note: Participation in the PBV Program requires compliance with Fair Housing and Equal Opportunity Requirements, and Federal Labor Standards will apply to eligible projects.
